In our team meeting today, we discussed the cleanup fund and reimbursement. Earlier today, I approved an extension for this site to allow for pre-approval of the site characterization work but my new understanding from the meeting is that site investigation is not contingent on reimbursement of funds. So this work must be performed either with or without preapproval by the Fund. I looked at the original request date and report submittal date and since my request was made over three months ago with a due date of January 5, 2009. I will extend the due date until February 27, 2009.

Please note that late submittals may cause noncompliance which may affect your reimbursement status with the cleanup fund.

Fyi, we are currently submitting a pre-approval request to the UST Fund for the site characterization work and modification to the groundwater monitoring program. We need assurance from the Fund that we will be fully reimbursed for the work. Therefore, we will need an extension for submittal of Soil and Water Investigation Report. I will look into revising the SOP. If the depth of the probe allows it, we will have (from bottom to top):

- 12" sand pack
- 12" dry granular bentonite
- At least 12", but should be to top of boring, hydrated bentonite.
- This should be topped with either concrete to set a well box, or a 2"-6" layer of dry bentonite, depending on how the well will be finished.
