There was some confusion on our part regarding the closure of this case. We are in the process of obtaining permits to destroy the on-site wells and wells located in the public right-of-way; however, encroachment permitting to destroy the wells in the public right-of-way will likely extend beyond the March 14, 2014 due date. Therefore, RRM requests an extension of the technical report documenting the well destruction to May 14, 2014.
