Enclosed are four documents regarding the subject site, Notification of Discharge at the Former Texaco Service Station, dated August 17, 1995, Technical Review of Discharge at the Former Texaco Service Station, dated August 17, 1995, Notice of Deficient Report at the Former Texaco Service Station, dated August 18, 1995, and Permit Violation at the Former Texaco Service Station, dated August 30, 1995. The first three documents were sent to you directly. The fourth is being submitted to you for the first time with this letter.

These four documents are in response to your letters, Notice of Deficient Report, dated August 14, 1995, Violation of Wastewater Discharge Permit Limitation for Benzene, dated August 16, 1995, and Violation of Wastewater Discharge Permit Limitation for Benzene, dated August 30, 1995, all regarding two incidents of permit violation, one on May 3, 1995 when permitted benzene discharge limitations were exceeded by eight parts in ten billion and a second on July 5, 1995 when permitted benzene discharge limitations were exceeded by nine parts in ten billion.

Regarding the four attached documents, I certify under penalty of law that, to the best of my knowledge, these documents and all attachments were prepared under my direction or supervision in accordance with a system designed to assure that qualified personnel properly gather and evaluate the information submitted. Based on my inquiry of the person or persons who manage the system, or those persons directly responsible for gathering information, the information is, to the best of my knowledge and belief, true, accurate, and complete. I am aware that there are significant penalties for submitting false information, including the possibility of fine and imprisonment for knowing violations.

I presume that these attached documents, as well as both my and Texaco's consultant's verbal responses to these incidents of violations are satisfactory to meet your Agency's permit requirements and that the issue may now be closed.
