The following documentation concerns the sampling of approximately 15 cubic yards of soil stockpiled at 1127 Lincoln Avenue, Alameda, California, on May 7, 1990.

The 15 cubic yards of soil sampled represents the remaining portion of the approximately 200 cubic yards of soil generated during the removal of five underground storage tanks at the site on September 11, 1989. Sampling was conducted to determine residuals levels of hydrocarbons remaining in the soil.

SAMPLING

In accordance with Bay Area Air Quality Management District guidelines, a single sample, consisting of three brass sample containers, was collected for subsequent analysis as a composite sample.

SAMPLING METHODOLOGY

The samples were contained by driving clean brass tubes (1.92" x 6") into the exposed layer of soil. Soil was packed into the tubes to eliminate the possibility of headspace within the sample container. Thus prepared, the ends of the tubes were wrapped with aluminum foil and sealed with plastic caps. After removing excess foil, electrical tape was applied to the seams between cap and tube in an effort to reduce the evaporative loss of volatile constituents.

SAMPLE ANALYSIS

The samples were placed on ice in a cooler and transported under chain of custody documentation to Anametrix, Inc., a certified hazardous materials testing laboratory (HMTL #151) to be analyzed for total petroleum hydrocarbons (TPH) calculated as gasoline and benzene, toluene, xylenes, and ethylbenzene (BTX&E) on a 48 hour rush turnaround.

Analytical methods used by Anametrix, Inc. were consistent with analytical procedures outlined by the San Francisco Bay Regional Water Quality Control Board (SFRWQCB).

RESULTS

The certified analytical report which discusses the findings of sample analysis has been attached to this sampling report.

Sample #1A-C did not contain levels of TPH as gasoline or BTX&E above the respective limits of detection for each of these constituents.

RECOMMENDATIONS

Based on the results of sample analysis, the 15 cubic yards of material are eligible for disposal at an accepting class III landfill.


