Jerry,

We appreciate your granting the extension for the Corrective Action Plan (CAP) to June 15, 2012. Per our conversation, we understand that the CAP will include an evaluation of remedial action options and a proposed action focused on commercial\industrial closure. We also understand that closure may be granted by Alameda County once the accepted action is implemented, which may include a land use deed restriction covenant and possible soil and water management plan.

PG&E does do not anticipate the site's use changing from its current use in the foreseeable future. Currently the site is used to store heavy equipment and baker tanks for the PG&E hydrostatic testing program. The extensive use of the site for temporary storage, particularly the baker tanks, prevent us from implementing any proposed corrective action in the next year.
