This law firm represents William H. Broach, the duly appointed Chapter 7 trustee in the above-referenced bankruptcy case. At your request, I have summarized below the status of this case and the trustee's relationship to the property located at 800 West Grand Avenue, Oakland, California, which property is the subject of a Alameda County Environmental Protection Division Pre-enforcement Review Panel convening February 28, 1995.

On December 14, 1993, Patrick Swasey, the debtor in this bankruptcy case, filed a Chapter 7 bankruptcy petition (a copy of the schedules are attached to this letter). He listed Meaders Drapery & Carpet Cleaners as a dba. The primary non-exempt asset in the case was 800 West Grand Avenue, Oakland, the real property at which the business was located.

The property was scheduled with a market value of \$380,000 and encumbrances of \$242,000. When the trustee investigated the possibility of administering this asset (i.e., selling it), experts confirmed that the property needed seismic work and a new roof. The broker who had listed the property for the debtor (pre-bankruptcy filing) also produced a Transaction Screen conducted by International Geologic, indicating that the County had requested monitoring wells and that remediation might be required. These facts and our discovery that the debtor's

ex-spouse had an unscheduled lien in the amount of \$80,000 led us to the inevitable conclusion that the property had a negative value and could not be administered. Each of the other assets similarly turned out to be worthless or non-existent and the trustee began to move towards closing the case.

Sumitomo Bank holds the first mortgage on the property and its deed of trust contained an assignment of rents clause. Accordingly, all rents from the property (except \$1,000, to cover administrative expenses) have been turned over to the bank. The case will be closed as a no-asset case. The trustee has not formally abandoned the property, but has no intention of administering it. Under the Bankruptcy Code, the property will be deemed abandoned and revert to the debtor upon the closing of the case.

In our investigation we conducted a computer UCC search. This revealed an IRS lien on "Kearn and Swasey, a Partnership" located at the debtor's business address. That is all the information we have with respect to that partnership.


