REPORT OF QUARTERLY GROUNDWATER SAMPLING

GRANHOLT SHEET METAL 501 San Pablo Avenue Albany, CA stide





Figure 1. Site Location Map.

On March 22, 1993, the one on-site monitoring well was sampled for the laboratory analysis for dissolved petroleum constituents. The location of the site is shown in Figure 1 (site location map).

Monitoring Well Sampling and Laboratory Analysis

On March 22, 1993, the one on-site well was purged, and groundwater samples were subsequently collected. The location of the monitoring well is shown in Figure 2 (site map). Prior to groundwater sampling, the well was purged by bailing several casing volumes of water. Field conductivity, temperature, and pH meters were present on-site during the monitoring well sampling. As the purging process proceeded, the three parameters were monitored. Purging continued until readings appeared to have reasonably stabilized. After the

water level in the well had attained 80% or more of the original static water level, a groundwater sample was collected using a clean teflon bailer. The water sample was placed inside appropriate 40 mL VOA vials free of any headspace. The samples were immediately placed on ice, then transported under chain-of-custody to the laboratory at the end of the work day.

At the time the monitoring well was sampled, the following information was recorded in the field: 1) depth-to-water prior to purging, using an electrical well sounding tape, 2) identification of any floating product, sheen, or odor prior to purging, using a clear teflon bailer, 3) sample pH, 4) sample temperature, and 5) specific conductance of the sample. A copy of the well sampling log is included as Attachment A.

All analyses were conducted by a California State DOHS certified laboratory in accordance with EPA recommended procedures. All groundwater samples were analyzed for Total Petroleum Hydrocarbons as Gasoline, and Benzene, Toluene, Ethylbenzene, and Total Xylenes (BTEX).

Water Level Measurement.

The shallow groundwater elevation in MW-1 was measured as 4.58 feet below ground surface on March 22, 1993.

Laboratory Results.

Table 1 presents the results of the laboratory analysis for TPH and BTEX of the groundwater samples collected from monitoring well MW-1.

For this round of sampling, dissolved Gasoline was detected in the one shallow groundwater sample at a concentration of 3,900 μ g/L (ppb). In addition, dissolved Benzene, Toluene, Ethylbenzene, and Total Xylenes were detected at concentrations of 8.2 μ g/L (ppb), 8.5 μ g/L (ppb), 17 μ g/L (ppb) and 42 μ g/L (ppb), respectively.

A copy of the laboratory certificate for the water sample analyses is included as Attachment B.
