Dear Nissan and Carol Saidian, and Mr. Zektser,

Alameda County Environmental Health (ACEH) understands that Ms. Kelly York of the Chevron Environmental Management Co. (the active Responsible Party for the subject fuel release case) and her consultant Ms. Toni DeMayo of ARCADIS, Inc. have previously requested access to your property (and the property listed above) to conduct an environmental subsurface investigation. Ms. York and Ms. DeMayo have informed ACEH that access has not been obtained since you have not responded, nor signed and returned an access agreement. The purpose of this letter is to advise you in your decision regarding access.

A hydrocarbon release occurred at your 5910 MacArthur Boulevard property and has contaminated soil and groundwater beneath that site. As the active Responsible Party, Ms. York has been required by ACEH to investigate the extent of the release(s) and to clean up the contamination. The extent of the contamination is currently unknown. For this reason for Ms. York, and her consultant Ms. DeMayo, have requested access to determine the full extent of the soil and groundwater contamination.

ACEH encourages you to work with Ms. York, and her consultant, and agree upon the terms necessary (i.e. your signature on an access agreement) to allow them temporary access to your property to conduct the required work. All Responsible Parties for a site, including you, are responsible for the cost of investigation and cleanup of contamination to the extent required by the State. If you continue to deny access or do not respond by the date specified below, then this Agency and the Regional Water Quality Control Board may require you, rather than Chevron, to assume the active Responsible Party position at the site and assume costs associated with the investigations. Since the costs for such investigations are often high, allowing access is clearly more reasonable and in your financial interests. Please reconsider the request to access your property previously sent Ms. York and Ms. DeMayo and respond to this correspondence within twenty-one (21) days from the date of this letter with your decision.
