Hi Mark,

Thank you for returning my phone call Thursday, May 15 regarding the site investigation at this site.

As I have explained, we continue to experience delays in the investigation due to obtaining encroachment permits and well installation permits due to the approval period/process from the City of Oakland.

ARCADIS received the necessary documentation on April 25, 2014, from the site owner in order to obtain well installation permits and encroachment permits from the City of Oakland. Since then, ARCADIS has submitted the applications for encroachment on April 25 and have followed up with the City consistently through e-mails and phone calls, but we have not received the necessary permit approvals to move forward with our work. ARCADIS made a follow up call with the City again today and found out that the inspector, and person who approves the permits, has been out on vacation for two weeks and will return next week. ARCADIS will go to the permit desk in person early next week to see if we can obtain the permits.


As I discussed with you last week, we would like to request an extension for the report submittal to August 29. This will give us enough time to obtain permits, complete the field work, write the report and have the report pass through it's reviewing period in house and with the client.
