Alameda County Environmental Health (ACEH) has received the May 26, 2015 *Supplemental Groundwater, Soil Vapor and Soil Matrix Sampling In Support of Site Closure under Low Threat Closure Policy* (Report) submitted by LRM Consulting, Inc. on behalf of the Responsible Parties. In order to facilitate completion of our review, please submit a Report that includes the following required items in an Appendix to the Report:

1. The boring logs for SB-14 and SB-15;
2. The soil boring/soil vapor point permits from Alameda County Public Works Agency.

Additionally, ACEH received an e-mailed copy of the *Draft Soil Vapor and Soil Matrix Sampling (Work) Plan* on March 13, 2015. Please upload the Final Soil Vapor and Soil Matrix Sampling (Work) Plan as indicated below.

TECHNICAL REPORT REQUEST

Please upload the complete Soil and Groundwater Investigation Report that includes the requested Appendix to the ACEH ftp site (Attention: Karel Detterman), and to the State Water Resources Control Board's Geotracker website, in accordance with Attachment 1 and the following specified file naming convention and schedule:

- **July 31, 2015 – Final Soil Vapor and Soil Matrix Sampling Work Plan**
File to be named: RO134_WP_R_yyyy-mm-dd
- **August 10, 2015 – Final Soil and Groundwater Investigation Report**
File to be named: RO134_SWI_R_yyyy-mm-dd

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.
