Dear Ms. Strough and Mr. Berkovich:

Alameda County Environmental Health (ACEH) is considering the above referenced site for potential case closure. The public notification period ended on February 17, 2016 and no comments were received, so you may now decommission all on-and off-site wells including, but not limited to, groundwater monitoring, vapor monitoring, air sparging, extraction and injection wells. Please submit a *Well Decommissioning and Disposal Documentation Report*, which includes the Alameda County Public Works Agency (ACPWA) well destruction permits, signed waste profile and signed disposal documentation, including the signature of the receiving facility for the waste (both well decommissioning and remaining site waste) according to the following schedule. Please note that non-contaminated construction debris, such as well boxes, do not typically require manifested waste disposal.

TECHNICAL REPORT REQUEST

Please upload the technical report to the ACEH ftp site (Attention: Karel Detterman), and to the Geotracker website, in accordance with the following specified file naming convention and schedule:

- April 29, 2016 – Well Decommissioning and Disposal Documentation Report

This report is being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.
