Good afternoon Karel,

We have received the City of Oakland "excavation" permit to remove the well in a public right away, and are in the process of obtaining the City of Oakland encroachment permit/traffic control plan. We will submit the well destruction permit application to ACPWA on Monday. When we pin down a date with the driller we can circle back around with the City and wrap up the encroachment permit (always seems to be a chicken and egg scenario with encroachment permits). Obtaining the ACPWA drilling permit is always a smooth process, it's

the City permits that are slowing this down. Thanks for your patience, we'll follow up on Monday when we have a date pinned down for the well destruction.
