#### 1.0 INTRODUCTION

Clayton Environmental Consultants, Inc. was retained by Mr. Joseph S. Munyer, shopping center manager for Harsch Investment Corporation, to supervise removal of three sumps and sample underlying soils at the Southshore Car Wash (former Chevron Car Wash) on the corner of Park Street and Shore Line Drive in Alameda, California (Figure 1). Mr. Munyer authorized the project by approving Clayton's revised Proposal No. 90-B-217, dated September 18, 1990.

A copy of the closure plan for the sumps which was submitted to the Alameda County Health Agency (ACHA) and the City of Alameda and the permit from the City of Alameda are included as Appendix A.

#### 2.0 SUMP REMOVAL AND SOIL SAMPLING

Clayton commenced field activities for removal of the three concrete sumps at the site on October 30, 1990. Tom Daniels Excavating, Inc., from Danville, California, provided the excavation services under subcontract to Douglas Construction. Figure 1 shows the locations of the sumps.

The concrete sumps were removed, crushed into small pieces, and hauled to an appropriate landfill by Tom Daniels Excavating, Inc.

Ms. Cynthia Chapman, hazardous materials specialist with the ACHA, was onsite to observe sump removal and subsequent soil sampling events.

To collect undisturbed soil samples, Clayton removed soil exposed by excavation in the sampling area and advanced the brass tube into the floor of the pit with a clean rubber mallet until the brass tube was filled with soil.

Soil samples were collected at a depth of 8 feet below ground surface (bgs) for sump SA-1, 7 feet bgs for sump SB-1, and 6 feet bgs for sump SC-1. Samples were collected in 2-inch diameter brass tubes, each measuring 6 inches long. The tube ends were covered with aluminum foil, capped with plastic caps, and sealed with duct tape. The tubes were labeled and placed into a pre-cooled ice chest chilled to 4°C prior to shipment to Clayton's state-certified laboratory in Pleasanton, California. Upon delivery to the laboratory, a chain-of-custody form was completed listing analyses required. This form is included as Appendix B.

#### 3.0 LABORATORY RESULTS AND DATA ANALYSIS

The results of the laboratory analyses of selected samples were reviewed and compared to federal and state regulatory action levels and the guidelines set forth in the Leaking Underground Fuel Tank (LUFT) Field Manual. The results of analyses of the soil samples are presented in Appendix C.

Soil samples collected on October 30, 1990, were analyzed using:

• EPA Method 8015 Total Petroleum Hydrocarbons as Diesel

• EPA Method 418.1 (Modified) Total Recoverable Hydrocarbons as Oil and Grease

• EPA Method 8015/8020 Benzene, toluene, ethylbenzene, and xylenes

(BTEX)/Gasoline

EPA Method 6010 Lead and Zinc

Chemical constituents that were detected were below applicable action levels. Results of the laboratory analyses from Sumps SA-1, SB-1, and SC-1 are shown in the following table:

The laboratory did not detect any of the other compounds for which they conducted analyses, as shown in the laboratory reports provided in Appendix C.



### 4.0 CONCLUSIONS AND RECOMMENDATIONS

Based on the laboratory results for the soil samples, we recommend no further remediation in the vicinity of the sumps. Ms. Chapman was notified of the laboratory results and concurs with our recommendation.




