In your letter dated September 21, 2007, you requested that Shell prepare a Draft Corrective Action Plan (draft CAP) for submittal by December 12, 2007, to evaluate remedial alternatives to meet target clean-up goals for onsite contamination.

In response, CRA prepared a site conceptual model and geologic cross sections to better understand the site conditions and to assist with meeting the agency's directive for a CAP. At this time the SCM and cross sections have been prepared in draft and are being reviewed and revised in preparation for review by Shell, prior to agency review. In order to determine applicable cleanup goals for this site, CRA is also in the process of reviewing the contaminant concentrations in various media in relation to the recently revised Environmental Screening Levels document issued by the SFBRWQCB on November 15, 2007.

Given the upcoming holiday schedule, Shell's internal request for a 30-day review of SCM's and CAP documents, and the recent changes in the ESLs, CRA respectfully requests a 60-day extension (to **February 12, 2008**) for submittal of the SCM, geologic cross sections, ESL evaluation, and Draft CAP.

Your consideration with regard to our request for an extension is appreciated.

It should be noted that the vapor sampling of the offsite vapor probes was conducted on October 31, 2007. A monitoring report is being prepared and will be submitted by **January 15, 2008**.
