Dear Mr. Wickham,

In a November 6, 2008 letter, Alameda County Health Care Services Agency (ACHCSA) requested that a shallow soil investigation work plan be prepared to define the extent of lead detected in soil cuttings generated from the installation of soil vapor probe boring VP-9. CRA would like to request an extension to the January 8, 2009 due date to adequately prepare the Work Plan. Therefore, we request a 30 day extension to sufficiently prepare and review the Work Plan prior to submittal to ACHCSA.

On another note, CRA personnel visited the site on December 30, 2008 to collect a soil vapor sample from VP-9. The vapor probe contained so a representative sample was not collected and will be addressed in our upcoming fourth quarter 2008 groundwater and soil vapor monitoring report. As agreed upon in the ACHCSA's November 6, 2008 letter, CRA will collect a soil vapor sample from VP-9 quarterly and from VP-7 and VP-8 semi-annually (first and third quarter).
