Hi Lance -

Thank you for responding so quickly. The work we need to perform in the courtyard consists of:

1. Surveying the precise lateral and vertical (elevation) of all wells installed in the courtyard. This information allows us to better interpret the ground water gradient. The actual survey work would be performed by a licensed professional surveyor under subcontract to us, and should take just a few hours.

2. Measuring the depth to ground water in the wells and collecting samples of ground water and soil gas from the wells installed in the courtyard. This information will allow us to interpret the ground water gradient and evaluate the quality of ground water and soil gas over time. The field effort should take about 1-2 days.

Both tasks are typical for environmental investigations and monitoring.

Please let me know if you need more information, I'm happy to answer any questions.
