My mother passed on to me letters dated July 24, 2009 regarding the site at 6159 Acacia Avenue. The original home burned down during the Oakland Hills Fire. Prior to rebuilding, my family removed the underground tank and contaminated soil. A new home was built which was sold in 1999.

This paperwork is the first news I have received regarding any possible non-compliance since title transferred to the new owners. Prior to having the tank removed, it was the Shenk family's understanding that abandoned residential heating tanks were exempt from all city, county, state and federal oversight thus I have concerns why my mother received this correspondence. We were told we could just leave the tank alone; however, we thought we were taking the sound environmental approach by removing the abandoned tank and contaminated soil. The NOTICE OF VIOLATION letter dated July 24 is of particular concern as all available cleanup was done with the process monitored by representatives from the city and county, possibly even state and federal. A certificate of occupancy was supplied by the City so we thought we were in compliance with all requirements. What more needs to be done to close this case?

I attempted to "claim the site" via www.geotracker.waterboards.ca.gov but did not find any link at the site to make the claim. I would appreciate a call to resolve this obvious long-standing issue.
