Dear Mr. Hill:

This is a notice of an enforcement referral for the subject site. Site Responsible Parties are non-responsive to Alameda County Environmental Health (ACEH) requests and are recalcitrant. As a consequence, ACEH is referring this site to the San Francisco Bay Regional Water Quality Control Board for enforcement actions.

Site Background

Four USTs (gasoline and waste-oil) were removed from the site. Groundwater concentrations of up to 220 µg/L total volatile hydrocarbons (TVH-gasoline), 1,400 µg/L 1,2 -Dichloroethane, and 770 µg/L chloroform were detected. MTBE analysis was not performed. A composite soil sample was collected from the backfill. Sample results were 29 mg/kg total volatile hydrocarbons (TVH-gasoline), 230 mg/kg total extractable hydrocarbons (TEH- diesel), and 1.4 mg/kg benzene. Odors were also reported in the stockpiled soil. The soil was placed back in the tank pit for later removal. No documentation to confirm off-site soil disposal was submitted.

A work plan was submitted in November 1993 and approved in November 1993, but not implemented. A subsequent request for an updated work plan was made in July 2011. In addition, requests to claim the site were made on July 3, 2008, and a Notice of Violation was sent on February 14, 2011. No response has been received and the site remains unclaimed.
