Site Location: 1285 Bancroft Avenue, San Leandro, CA 94577 Fuel Leak Case RO0000156 and Geotracker Global ID T0600101224

Summary – This fact sheet has been prepared to inform community members and other interested parties of potential case closure for a fuel leak case at 1285 Bancroft Avenue in San Leandro, California (see attached map on back). Site investigation and cleanup activities have been completed and it does not appear that the fuel release presents a risk to human health based upon current and projected future land use as a gasoline service station. Case closure will be granted for commercial land use only. Site investigation activities, which have been conducted at various times since 1992, have defined the extent of petroleum hydrocarbons in soil and groundwater at the site. Recent soil sampling indicates that soils beneath the site contain relatively low concentrations of petroleum hydrocarbons. Soil vapor sampling conducted in 2008, indicates that subsurface vapors do not pose a risk of indoor vapor intrusion to site workers or residents of nearby properties.


Petroleum hydrocarbons are present in a groundwater plume beneath the site that extends approximately 100 feet southwest from the site. Groundwater is typically encountered in the area of the site at depths of 30 to 40 feet below ground surface. Based on the groundwater monitoring, which was conducted from March 1990 until December 2009 using 13 on-site and off-site monitoring wells, petroleum hydrocarbon concentrations appear to be decreasing and the groundwater plume appears to be shrinking in size. Further restoration of groundwater quality is expected to take place by natural attenuation processes.

Background -

The site is an active Shell-branded service station located at the corner of Bancroft Avenue and Estudillo Avenue in San Leandro, California (see attached map on back). During a site investigation in 1990, petroleum hydrocarbons typical of gasoline were detected in groundwater collected from a monitoring well. The fuel system components consisting of underground storage tanks, dispensers, and product piping were upgraded or replaced in 1995, 2003, and 2005. Site investigation activities consisting of soil, soil vapor, and groundwater sampling were conducted at the site at various times between 1992 and 2009. Remedial actions taken at the site include weekly groundwater extraction from three wells between September 1998 and July 1999 and monthly dual-phase extraction of vapor and groundwater from two wells between November 2000 and January 2005.

Next Step – The public is invited to review and comment on the potential closure of the fuel leak case.
