PIERS Environmental Services Inc. has prepared this letter in response to the State Water Resources Control Board's (SWRCB) "Request for Additional Information, Petition for Case Closure of Underground Storage Tank Site, 3744 Depot Road, Hayward, Alameda County, American Auto Wreckers, and Fuel Leak Case No. R00000161, SFBRWQCB Case #01-2091, GeoTracker ID T060000101922" letter dated February 24, 2010. The SWRCB requested additional information for "any water supply well that may be located at the site." Please find PIERS responses to the specific questions below. In addition, please be advised that the following statements are "to the best of our knowledge" regarding the one on-site "water supply well".

1) Description of well use: According to Riverbend Properties representative, Mr. Eric Freeberg, and to the on-site tenant, Mr. Feroz, (both Responsible Parties for the case), the non-potable water occasionally drawn from the one agricultural supply well on the site (MW #3) "is used only for watering a few outdoor plants and has never and shall never be used for any other purpose." The well designated as MW#3 on PIERS reports and site plans has no permit or installation records that PIERS is aware of. Nothing is known about this well except that it consists of a six-inch casing at the surface, and the total depth was previously measured at 30.5 feet below grade. It is shown on multiple versions of PIERS site plans (included in PIERS reports for the site since 1995). In addition, the well has been regularly monitored and sampled along with the other monitoring wells on the subject Property.

There is no municipal or private potable water source on/for the site The employees and tenants use hand cleaner and towels or bottled water to wash their hands. Bottled water (cases from Costco) has been and is currently used as the only source of drinking water on the site. This same bottled water is used for all other additional activities on the site.
