Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- 3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- 4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

ACEH has named the responsible parties for this site as detailed below.

Responsible Party Identification

Existence of Unauthorized Release

On November 11, 1997, three soil samples were collected beneath the dispensers during an upgrade to add secondary containment to three existing dispensers and turbine sumps. The soil samples contained up to 59 parts per million (ppm) of total petroleum hydrocarbons as gasoline (TPHg), 0.76 ppm of benzene, and 1.1 ppm of MTBE. Subsequent site investigation and groundwater monitoring have confirmed the presence of petroleum hydrocarbons in soil and groundwater beneath the site. Based on the site characterization data, an unauthorized release or releases occurred from the UST system.

Responsible Party Identification

Shell Oil Products is a responsible party for the fuel leak because they were the business owner, tank owner, and tank operator at the time of the unauthorized release (Definition 1), were the property owner at the time of the unauthorized release (Definition 3), and had control of the UST at the time of or following an unauthorized release (Definition 4).

Bansal, Inc. purchased the property in November 2012. Bansal, Inc. is a responsible party because they are the current owner of the property where an unauthorized release occurred (Definition 3).
