Paresh:

The postal mail just came in TWO minutes before I read your e-mail. The timing was interesting, isn't it? You are right. Mails takes a few days. In fact, I just lost five days (7/24 letter signed, 7/29 arrived).

The reported/employed TOC elevation was approximately 159-160 feet above msl. However, the topo for that area is only about 58-60 feet above msl.

Some area of Oakland is only 20 feet above msl. That is how we found that the survey was incorrect. We have contacted the original survey company.

They have not responded our request yet. We will re-survey if the original survey company (PLS) cannot correct it.
