Dear Mr. Sekhon and Mr. Ghaffar:

Alameda County Environmental Health (ACEH) staff has reviewed the case file for the abovereferenced site including the recently submitted document entitled, "Data Gap Work Plan Addendum," dated January 19, 2009, which was prepared by Environmental Risk Specialties Corporation (ERS) for the subject site. ERS proposes to install shallow and deep groundwater monitoring wells, collecting water samples and preparing Still Diagrams to determine whether shallow and deep water-bearing units are connected, while postponing aquifer pumping until the pilot testing phase, and continuing quarterly groundwater monitoring of existing and proposed groundwater monitoring wells.

ACEH generally concurs with the proposed scope of work and the proposed scope of work may be implemented provided that the modifications requested in the technical comments below are addressed and incorporated during the field implementation. Submittal of a revised Work Plan Addendum is not required unless an alternate scope of work outside that described in the Work Plan, Work Plan Addendum, and technical comments below is proposed.

We request that you address the following technical comments, perform the proposed work, and send us the technical reports requested below.

TECHNICAL COMMENTS

1. Preferential Pathway Study - In order to evaluate the potential for groundwater contaminant migration along utility corridors, please collect "grab" groundwater samples from borings installed within the groundwater contaminant plume located down-gradient of the site on Foothill Boulevard. Borings should be located up-gradient a few feet of the utility corridor, in the backfill of the utility corridor, and a few feet down-gradient of the utility corridor. Please analyze the "grab" groundwater samples for total petroleum hydrocarbons (TPH) as gasoline (g), benzene, toluene, ethylbenzene, and xylenes (BTEX), fuel oxygenates methyl tertiary butyl ether (MtBE), ethyl tert-butyl ether (ETBE), tertamyl methyl ether (TAME), diisopropyl Mr. Sekhon and Mr. Ghaffar RO0000175 February 6, 2009, Page 2

ether (DIPE), as well as alcohol compounds, such as tert-butyl alcohol (TBA). Please submit a revised figure that illustrates all proposed boring and well locations, due by the date specified below.

2. Proposed Monitoring Well Locations – On Page 13 of the above-mentioned work plan addendum, ERS states that groundwater samples will be collected from proposed well clusters MW-13A/MW-13B. On Table 1 of the same work plan, the proposed well construction data and rationale for the proposed well clusters MW-13A/MW-13B is presented. However, on Figure 3 monitoring well MW-13B is not proposed. Please submit a revised figure that illustrates all proposed boring and well locations, due by the date specified below. Also, please revise the figures in the upcoming report so that all boring and monitoring well locations, including monitoring well MW-13B, accurately depicted.

NOTIFICATION OF FIELDWORK ACTIVITIES

Please schedule and complete the fieldwork activities by the date specified below and provide ACEH with at least three (3) business days notification prior to conducting the fieldwork, including routine groundwater sampling.

TECHNICAL REPORT REQUEST

Please submit technical reports to ACEH (Attention: Paresh Khatri), according to the following schedule:

- February 18, 2009 Revised Site Figure
- April 30, 2009 Quarterly Monitoring Report (1st Quarter 2009)
- May 4, 2009 Soil and Water Investigation Report
- July 30, 2009 Quarterly Monitoring Report (2nd Quarter 2009)
- October 30, 2009 Quarterly Monitoring Report (3rd Quarter 2009)
- January 30, 2010 Quarterly Monitoring Report (4th Quarter 2009)

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used

for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is required in GeoTracker (in PDF format). Please visit the SWRCB website for more information on these requirements (http://www.swrcb.ca.gov/ust/electronic submittal/report_rqmts.shtml.

PERJURY STATEMENT

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety

SUBJECT: Electronic Report Upload (ftp) Instructions

Effective January 31, 2006, the Alameda County Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of all reports in electronic form to the county's ftp site. Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities.

REQUIREMENTS

- Entire report including cover letter must be submitted to the ftp site as a single portable document format (PDF) with no password protection. (Please do not submit reports as attachments to electronic mail.)
- It is preferable that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements must be included and have either original or electronic signature.
- Do not password protect the document. Once indexed and inserted into the correct electronic case file, the
 document will be secured in compliance with the County's current security standards and a password.
 Documents with password protection will not be accepted.
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
- Reports must be named and saved using the following naming convention:

RO#_Report Name_Year-Month-Date (e.g., RO#5555_WorkPlan_2005-06-14)

A separate copy of the tables in the document should be submitted by e-mail to your Caseworker in Excel format.
 These are for use by assigned Caseworker only.
