WORK PERFORMED THIS PERIOD (First Quarter 2011):

- 1. ACEHD, on February 10, 2011, conditionally approved a report titled *Feasibility Study Work Plan* (Work Plan) dated December 13, 2010. A scope of work to conduct a dual phase extraction remediation pilot test, an in-situ chemical oxidation groundwater remediation pilot test using ozone and hydrogen peroxide injection, and remediation well installation work needed to conduct these tests, was included in this document.
- 2. Stratus retained an underground utility locator to identify subsurface utility corridors in the southeastern portion of the site. This information was used to assist in developing a scope of work to supplement the December 13, 2010 *Work Plan*.
- 3. Stratus submitted a report titled *Addendum to Feasibility Study Work Plan (Addendum Work Plan)* on February 25, 2011, as requested by ACEHD in their February 10, 2011 letter. The *Addendum Work Plan* was approved by ACEHD, in electronic mail correspondence dated March 23, 2011.

WORK PROPOSED FOR NEXT PERIOD (Second Quarter 2011):

- 1. On April 6 and 7, 2011, Stratus directed the installation of two soil gas monitoring wells (SGW-1 and SGW-2), two nested injection wells (IW-1A/B and IW-2A/B), and one extraction well (EX-1) for use during pilot testing work. Well EX-1 will be developed before conducting the DPE pilot test.
- 2. During the April 6 and 7, 2011 work, Stratus observed that the vault box covering well MW-5 was damaged. Stratus will repair this vault box during the second quarter 2011.
- 3. Stratus will prepare and submit a report documenting the well installation work and associated findings.
- 4. Stratus will complete a DPE pilot test (tentatively scheduled during the week of April 25, 2011).
- 5. Stratus will initiate the ozone and hydrogen peroxide remediation pilot test. The test will continue into June 2011, or early third quarter 2011.
- 6. Stratus will conduct semi-annual groundwater monitoring and sampling activities during the second quarter 2011. During this event all monitoring wells will be gauged for depth to water and evaluated for the presence of free product. Following gauging, all wells will be purged and sampled. Samples

will be forwarded to a state-certified analytical laboratory for analysis. The groundwater sampling event will be performed after completion of the DPE pilot test, and possibly after completion of the ozone and hydrogen peroxide injection test (but not during the test).
