

WORK PERFORMED THIS PERIOD (Third Quarter 2011):

- 1. In accordance with SWRCB Resolution No. 2009-0042, this site is under a semi-annual groundwater monitoring and sampling (during second and fourth quarters each year) program; therefore, no groundwater monitoring/sampling was conducted during the third quarter 2011.
- 2. Stratus submitted an *In-Situ Chemical Oxidation Remediation Pilot Test Report*, dated September 23, 2011, which detailed the results of an ozone/hydrogen peroxide injection groundwater remediation pilot study conducted at the site in May and June 2011.

WORK PROPOSED FOR NEXT PERIOD (Fourth Quarter 2011):

1. Stratus will conduct semi-annual groundwater monitoring and sampling activities during the fourth quarter 2011. During this event all monitoring wells will be gauged for depth to water and evaluated for the presence of free product. Following gauging, all wells will be purged and sampled. Samples will be forwarded to a state-certified analytical laboratory for analysis.
