

1.0 INTRODUCTION

AEI has prepared this proposal on behalf of Mr. Roger Tan of Santini Foods, Incorporated, and outlines the scope and cost for a subsurface investigation at 16505 Worthley Drive, San Lorenzo, CA 94580. The following scope of work has been requested by the client and Eva Chu of the Alameda County Health Care Services Agency (ACHCSA) to collect data in order to pursue a closure request for the site.

In preparing this proposal, the client provided AEI with correspondence from the ACHCSA dated July 2, 2003 and July 16, 2003 that described the intended scope of work and current requirements.

i.e. WORK PLAN 2.0 SCOPE OF WORK

AEI will perform the following tasks to complete the proposed investigation:

- Obtain drilling permit for temporary soil borings from the Alameda County Public Works Agency.
- · Mark and notify Underground Service Alert North (USA) to identify public utilities in the planned work area(s).
- Notify current property owner of the nature and schedule of the work
- Drill and log a single soil boring at the property to a depth of 20 feet below ground surface (bgs), or to first encountered groundwater, whichever is shallower. Groundwater is expected between 6 and 16 feet bgs.
- Collect soil and groundwater samples and deliver for analysis at a state-certified laboratory. The following types and number of analyses are included:
- Backfill borings per State and County guidelines.
- Prepare a final technical report detailing methods and results of the investigation, including pertinent documentation such as figures, soil boring logs, and analytical documentation.

3.0 COST ESTIMATE

AEI will complete the stated scope of work for the total price of \$ 3,700.00, less \$1,000.00 if Santini Foods provides the drilling contractor, based on the following assumptions.

- One day in the field for drilling activities, and the work will occur during normal business hours (7:00 am - 4:30 pm) Monday through Friday.
- · Drilling will commence on private property, and the client will obtain written authorization from the property owner to perform this project. Client is responsible for providing access to the site and notification/coordination with on-site tenant(s). Delays caused by on-site personnel on the day of field work may result in additional costs.

- AEI will have clear access to the drilling locations with a truck-mounted direct push (Geoprobe™) drilling system.
- No underground or aboveground utilities are encountered.
- Refusal is not encountered prior to the target depth.
- Groundwater is present at expected depths, and recharge rates allow for sample collection.
- No concrete coring is required.
- Soil cutting and investigation derived waste will remain onsite. Disposal costs are not
 included. Upon receipt of analytical data, AEI can provide disposal estimates, if necessary.
- This contract includes drilling a total of 20 feet. If additional drilling is required over this amount in order to collect groundwater sample(s), a fee of \$ 100.00 will apply for every additional 10 feet of drilling or portion thereof.
- The samples will be analyzed with a standard 5 to 7 day turnaround time. If a more rapid turnaround of samples is required, the following additional costs apply, as appropriate.
