## **Reasons for Request for Transfer**

Representatives of the Responsible Party, ERS, ACEH, RWQCB, and SWRCB attended a meeting on April 15, 2009 to discuss the case. Generally, there was little concurrence with technical positions held by ACEH for the Site and the Petitioner believes that the potential to obtain a timely or cost effective case close is low. Based on technical opinions expressed in the meeting by SWRCB and RWQCB representatives, the Petitioner requests that all future regulatory oversight be provided by the RWQCB.

A copy of the denial letter is attached. We respectfully request that the case be transferred as soon as possible to facilitate performing any tasks necessary to justify full regulatory closure of the case.
