### Hi Eva,

Yes the meeting was moved up to March 23<sup>rd</sup>. The 30<sup>th</sup> got claimed by another case meeting first, and since we'd not heard back from "Chevron", and we were aware of Carryl's situation, we moved it up so we could meet with the project proponents.

Briefly - Project proponents are to submit the location of the Onsite Waste Water Treatment System (OSWWTS) to ACDEH by March 30<sup>th</sup> (tomorrow) to assist in the Chevron's Corrective Action Plan. The location of the onsite Public Water Supply Well is known, and project proponents determined on Monday or Tuesday (March 26<sup>th</sup> or 27<sup>th</sup>) the appropriate setbacks for a UST system to a public water supply well. Setbacks for the OSWWTS were known. ACDEH is targeting an April 6<sup>th</sup> directive letter to address the OSWWS and CAP milestones and submittal dates. An additional meeting with ACDEH, County CDA, and the CEQA consultant are planned for the week of April 9<sup>th</sup>, but don't require your / Chevron's presence.
