The Notification of Potential Case Closure requests that landowners or residents submit any comments or questions to Alameda County Environmental Health (ACEH) regarding potential case closure. Due to the new Low Threat Closure Policy, ACEH is required to notify public agencies and water agencies of a site's pending low-threat closure during the 60 day public participation period.
