In regards to the Fidelity Roofing site, no additional information has been generated since case closure in May 2013. The predominate groundwater flow direction was to the northwest, so I would consider there to be a relatively low likelihood of encountering contamination from the site at the pole replacement location. Depth to groundwater at well MW-5 was no shallower than approximately 9.2 feet below grade surface at that time, so your crew may not encounter groundwater.

In regards to the California Linen Supply site, you will need to communicate with Mark Johnson of the RWQCB as he has been working that site more recently than the County, and may know more current information. While ACDEH managed that case, there was a slightly higher probability of contamination from that site to impact your current work area.


