Alameda County Environmental Health (ACEH) staff has reviewed the case file including the October 13, 2014 *Ozone Sparging Pilot Test Report* (Pilot Test Report) and the November 13, 2014 *Post- Ozone Sparging Pilot Test Rebound Evaluation Report* (Rebound Report) both prepared and submitted on your behalf by P&D Environmental, Inc. in conjunction with the State Water Resources Control Board's (SWRCBs) Low Threat Underground Storage Tank Case Closure Policy (LTCP). Thank you for submitting the Pilot Test Report and Rebound Repots. The work proposed in the Rebound Report was discussed and tentatively agreed upon during a call with Paul King on February 4, 2015.
