## Dear Responsible Parties:

Alameda County Department of Environmental Health (ACDEH) staff has reviewed the above-referenced fuel leak case file for proposed case closure pursuant to California Health and Safety Code (H&SC) Section 25296.10 and the State Water Board's Low-Threat Underground Storage Tank Case Closure Policy (LTCP). Based on our review, ACDEH has determined that the site appears to qualify for case closure and therefore, no further action related to the underground storage tank fuel release is required at this time. ACDEH has sent out a public participation fact sheet which describes the site and the proposed case closure. Public comments on the proposed case closure had been accepted for a period of sixty (60) days beginning April 18, 2017 through June 18, 2017. ACDEH had not received any comments during this period, and to proceed to case closure, we request the proper destruction of all monitoring wells.
