Human health risk section can be brief with identification of potential pathways and comparison to ESLs and LTCO criteria.

Groundwater use section should discuss no extraction and withdrawal within area of plume and beyond. A buffer zone should be at least 1,000 feet from the plume and also a vertical distance for extraction.

The SMP may include a section that discusses future evaluation of site conditions when mining or development of the site is planned. Cannot predict when cleanup goals will be reached naturally so a site assessment would be advisable at the time of mining or development.
