Thanks for the brief chat, it sounds like you have your hands full. I primarily want to propose semi-annual monitoring for the Palace Garage facility located 14366 Washington, in San Leandro. Unfortunately our client is very poor and hasn't been able to authorize us to do any work. They have a request in with the Fund to change their claimant status from C to B which would improve things for them. Sadly the Fund isn't doing much of anything in that regard right now so we have been on hold and didn't do a first quarter 2009 report. Of course I would be happy to send you a quarterly summary report if you would like something formal in the file.

Since were on the topic of reductions, perhaps you would consider reducing the analyte list also? Groundwater has been analyzed for 5-oxygenates for 6 quarters and we have only ever detected MTBE at concentrations well below 5 ug/L. I would like to propose decreasing the analysis to just TPHg, BTEX by 8260. We have a great deal with our lab (Accutest) and with this change we can get the analytical costs down from \$85/sample to \$40/sample. I'm sure you are sensitive to the economic conditions out there with the Fund suspending so many claimants, this change would sure help. If you agree to all this you can just send me an email and I will put together a formal letter for your file.
