Dear Mr. Hill:

This is a notice of an enforcement referral for the subject site. Site Responsible Parties are non-responsive to Alameda County Environmental Health (ACEH) requests and are recalcitrant. The site has accumulated an extensive series of Notice of Violations from ACEH. As a consequence, ACEH is referring this site to the San Francisco Bay Regional Water Quality Control Board for enforcement actions.

Site Background

In May 1996 two 700-gallon USTs (one gasoline, one waste oil) and associated product piping were removed. Corrosion and holes were observed in both tanks. Up to 20,000 mg/kg total volatile hydrocarbons as gasoline, 13,000 mg/kg total extractable hydrocarbons as diesel, and 13 mg/kg benzene were detected in soil. No groundwater samples were collected or analyzed. The lateral and vertical extent of contamination is undefined. Also, vapor intrusion into the building has not been evaluated. Redevelopment is planned for the site.

Notices of Violation were submitted May 13, 1998, August 19, 1998, May 24, 2000, and July 17, 2000 for non-submittal of a work plan. A work plan was submitted on July 7 23, 2010 and ACEH approved the work plan on August 27, 2010. However, this work has not been performed to date. Additional notices of violation were issued in July 2009 and January 2011 for non-compliance with Geotracker regulations. No response has been received.
