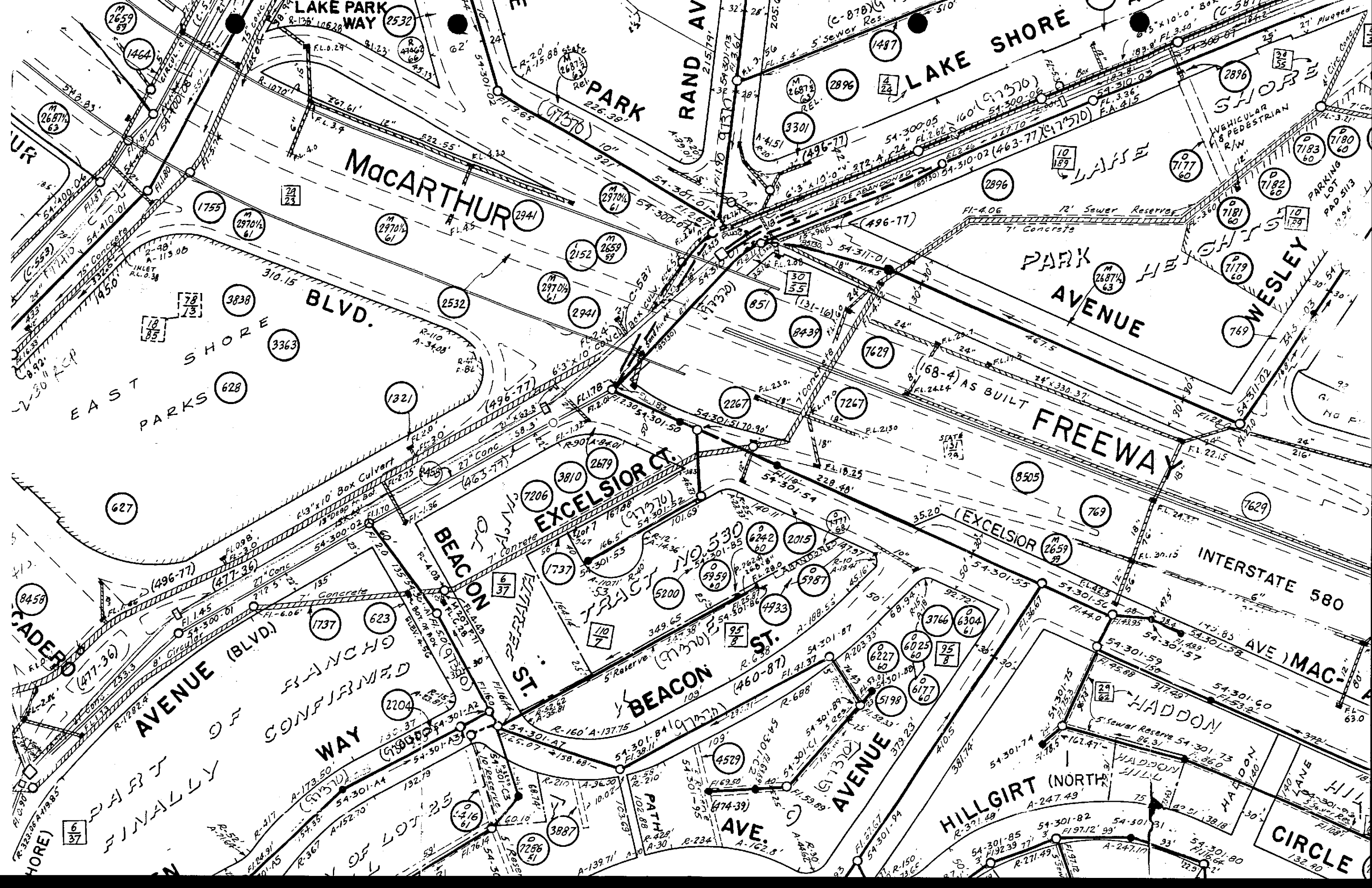
EXTENDED SITE PLAN
