Jerry,

Happy New Year! I would like to update you on the progress at the Harrison Commingled Site in Oakland. The Fund has not approved 2015-2016 budgets (due since July 1, 2015) for this site and others CVX commingled sites. The lack of approval has us concern about reimbursement.

In the meantime, PGE completed their electrical upgrade and trenching activity in September. Also, Arcadis completed the remaining remediation well installations in December. A Well Installation Report is in progress and will be submitted to ACEH by end of January. Chevron and Arcadis have identified a system/trailer for used at the site. The system/trailer lacks an air sparge unit which has been identified and we are currently working through the purchase order (lead time is estimated 8-10 weeks).

We will continue to provide you status updates as we progress through implementation. The above activities will not impact the routine groundwater monitoring and report schedule.
