For the referenced site, per your 3/30/12 letter we have a due date of 6/15/12 for submission of a soil and GW investigation report as well as GeoTracker compliance. Regarding GeoTracker, I uploaded all the older boring logs last month and they were accepted per Ross Wickham, so that item has been covered as that appeared to be all that was missing. However, regarding the investigation, unfortunately we have once again run into permit issues with the City of Oakland (they are a picky bunch) as well as making sure we have access to the properties to perform the work. The access issues are cleared up and we're good to go on that end, however, the permit issues are still being resolved, thus we have not had a chance to perform the work as of yet. It is in progress and we are working diligently to get everything ironed out, but the end result is we will not realistically be able to meet this deadline. Therefore, on behalf of Chevron, I wanted to inquire if an extension to, perhaps August 15th may be possible, to ensure an additional extension is not needed. Please let me know and I apologize for any inconvenience. Thanks.
