Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- 3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- 4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

ACEH has named the responsible parties for this site as detailed below.

Responsible Party Identification

Existence of Unauthorized Release

Fuel indicative of a release was observed during a product delivery on February 15, 1995. An Unauthorized Release Report was prepared on February 17, 1995. Subsequent site investigation activities have detected petroleum hydrocarbons in soil and groundwater over much of the site.

Responsible Party Identification

Rino Pacific Inc. was the business owner, tank owner, and tank operator at the time of the unauthorized release in 1995. Rino Pacific Inc. is a responsible party because they were the business owner, tank owner, and tank operator at the time of the unauthorized releases (Definition 1) and had control of the USTs at the time of or following an unauthorized release (Definition 4).

Lillian Earls and Tony Muir are responsible parties because they owned the property at the time of the release and are the current property owners (Definition 3).
