- 10/3/96 left message for Michael Jue, 510-582-3469, since he has not contacted this office since the 7/30/96 meeting. Inquired about groundwater monitoring report & status of Kay Ku's application to Trust Fund.
- 10/9/96 Left message for Mike Jue. Mentioned that if no progress is made on site, that it will be referred to DA's office or RW@CB.
- 10/9/96 Kay Ku, (510)467-9855, left message for her.
- 10/9/96 Lee Huckins, Tank Protect, called to say that the reason no sampling was conducted at the site was that Tank Protect forgot about the signed contract. They will sample well this month & get report out ASAP.
- 10/11/96 Michael Sims, 510-467-9855, called representing Ms. Kay Ku. Discussed requirements & info on the State Trust Fund. Mr. Sims stated that he would go ahead & apply to State Fund (or get ball rolling on application) on Monday.
- 10/23/96 Michael Sims called to say he is in process of filling out State Fund application and I faxed him copy of ULR
- 10/24/96 Michael Sims called. He informed County that ~~Mr. Mrs.~~ ~~Butter~~ Ms. Ku purchased property from Mr. & Mrs. Butler.
