Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- 3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- 4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

ACEH has named the responsible parties for this site as detailed below.

Responsible Party Identification

Existence of Unauthorized Release

In August 1990, the dispensers at the site were removed and replaced. Compliance soil sampling detected hydrocarbon contamination. Following dispenser replacement activities, a Preliminary Site Investigation was conducted at the site. Soil and groundwater impact was verified from previous release of gasoline fuel.

Responsible Party Identification

British Petroleum owned the subject property from circa May 1989 until August 1994. British Petroleum is a responsible party because it owned the USTs (definition 1), operated the USTs for storage of hazardous substances (definition 2), owned the property where an unauthorized release of a hazardous substance from an underground storage tank has occurred (definition 3), and had control over the USTs at the time of or following an unauthorized release of a hazardous substance (definition 4).

Conoco Phillips (corporate successor to TOSCO and Union Oil Company of California), owned the subject property from August 1994 until June 2004. Conoco Phillips is a responsible party because it (or corporations it acquired) owned the USTs (definition 1), operated the USTs for storage of hazardous substances (definition 2), owned the property where an unauthorized release of a hazardous substance from an underground storage tank has occurred (definition 3), and had control over the USTs at the time of or following an unauthorized release of a hazardous substance (definition 4).

Toan V. Nguyen purchased the property in June 2004. Toan V. Nguyen is a responsible party because he owns the property where an unauthorized release of a hazardous substance occurred (definition 3).
