Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R. Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

ACEH has named the responsible parties for this site as detailed below.

Responsible Party Identification

In March 1997 one-280-gallon waste-oil tank, two 12,000-gallon gasoline USTs and product piping were removed. Overexcavation samples were collected - no initial samples were collected. Soil samples collected from the waste oil tank excavation were below the detection limit for petroleum hydrocarbons, VOCs and SVOCs. Soil Samples collected from the gasoline USTs and dispensers contained maximum concentrations of 2.6 milligrams per kilogram (mg/kg) total petroleum hydrocarbons as gasoline (TPHg), 0.012 mg/kg benzene, and 1.4 mg/kg methyl tertiary butyl ether (MTBE). A water sample obtained from 16 feet in the tank pit contained 6,100 µg/L TPHg, 54 µg/L benzene.

Responsible Party Identification

Tosco Corporation purchased the property in 1997 and was the business owner, tank owner and property owner following an unauthorized petroleum hydrocarbon release(s). Tosco Corporation meets the definition of a responsible party for the site because they owned and operated the underground storage tanks (Definition 1), owned the property where an unauthorized release occurred, (Definition 3), and had or has control of an underground storage tank at the time of or following an unauthorized release (Definition 4).

The Andrew J. and Nila J. Coffin Trust purchased the property on December 19, 2003 and was the property owner following an unauthorized petroleum hydrocarbon release(s). The Andrew J. and Nila J. Coffin Trust meets the definition of a responsible party because it owns the property where an unauthorized release occurred, (Definition 3).

Conoco Phillips purchased TOSCO in December 2005. Conoco Phillips as a successor to Tosco is a responsible party for the site because they owned and operated the underground storage tanks (Definition 1), formerly owned the property where an unauthorized release occurred, (Definition 3), and had control of an underground storage tank at the time of an unauthorized release (Definition 4).

Safeway purchased the property on November 3, 2009 and is the property owner following an unauthorized petroleum hydrocarbon release(s). Safeway meets the definition of a responsible party for the site because they own the property where an unauthorized release occurred, (Definition 3).
