As you know, we are performing a geotechnical investigation for the proposed development at 3000 Broadway in Oakland. As requested, we will collect organic vapor meter measurements and will record them on the boring logs. I also wanted to inform you that we are planning on collecting one groundwater sample from the boring inside 3020 Broadway for construction/transaction due diligence. This boring is located over 150 feet upgradient of the former UST located at 260 30th Street and therefore, is not expected to be impacted by the abandoned-in-place UST at the site. We will make sure to properly abandon the boreholes with the county upon completion.

I would also like to take this opportunity to ask if you have had a chance to look at our closure request that was submitted for 260 30th Street last week. If you could let me know what your anticipated review time on that document is, we would appreciate it. I know you are very busy but if there is any way to expedite the review of this document it would be very helpful for the pending property transaction.
