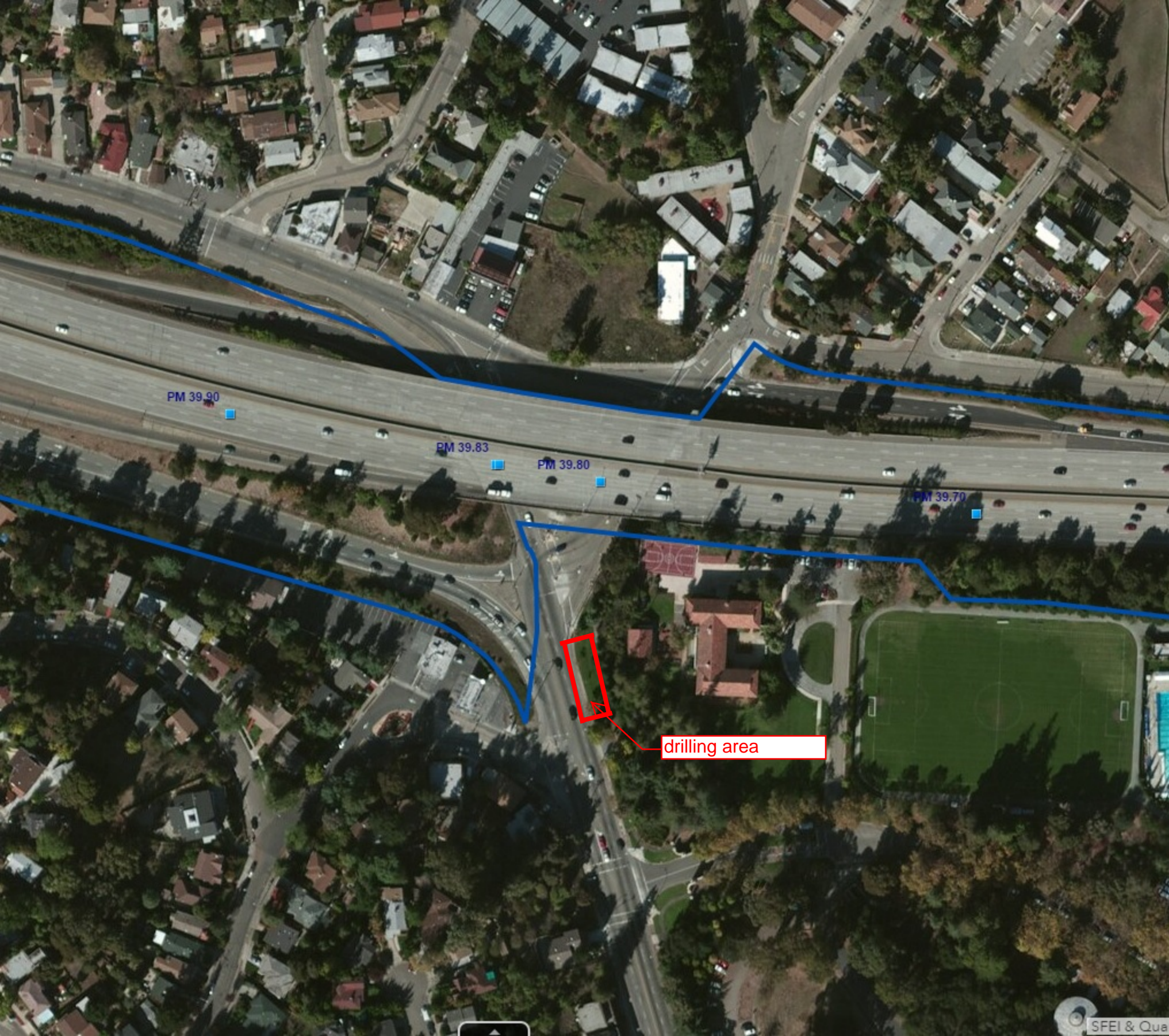
Will you be required to apply to Caltrans for an encroachment permit for advancing the soil bores for the next phase of work at the subject site?
