On behalf of ARCO Products Company (ARCO), Pacific Environmental Group, Inc. (PACIFIC) thanks you for your past cooperation associated with our ongoing groundwater investigation in your area. In a letter dated February 10, 1994, PACIFIC, on behalf of ARCO, requested your continued cooperation in regards to quarterly sampling and the discontinued use of the domestic irrigation well located on your property. To date, we have not received the signed copy of the authorization form sent to you. Therefore, we are sending you another copy in case the original letter has been lost.

As we described in previous correspondence, we are continuing to investigate the origin of impacted groundwater in the vicinity of your property at the direction of the Alameda County Health Care Services Agency. We currently expect our investigation to continue through 1994. Therefore, we are requesting your continued cooperation in the following areas.

First, PACIFIC requests your authorization to sample the water from your domestic irrigation well on a quarterly basis through 1994. Second, PACIFIC also requests that **if your well is operational**, you do not operate your well until the investigation is complete. In exchange for not operating your well, ARCO will reimburse you \$30 per month.

We would greatly appreciate your assistance in **completing the enclosed authorization form**, and returning it in the self-addressed, stamped envelope. Please note that this form provides spaces to accept or reject ARCO's requests.
