REPORT REQUESTS

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the GeoTracker database over the Internet. The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has
- "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

Responsible Party Identification

Existence of Unauthorized Release

On March 5, 1997 four underground storage tanks (UST) were removed from the site. Two of the USTs were determined to be of approximately 10,000-gallon capacity, one was determined to be of an approximate 6,000-gallon capacity, and the fourth was determined to be approximately 2,000-gallons in capacity. Concentrations up to 1,100 milligrams per kilogram (mg/kg) Total Petroleum Hydrocarbons as gasoline (TPH as gasoline), 550 mg/kg TPH as diesel, 11 mg/kg benzene, and 24 mg/kg ethylbenzene were documented in soil samples collected at the time. The data indicate that an unauthorized release has occurred at the site.

Responsible Party Identification

Mohinder S. & Joginder K. Sikand acquired the property in March 1973 and are a responsible party for the site because they owned the UST used for the storage of a hazardous substance (Definition 1), and owned the property associated with an unauthorized release (Definition 3).

Jasminder & Sonia Sikand acquired the property in August 2007 and are a responsible party for the site because they owned the property associated with an unauthorized release (Definition 3).

Anis Rahman operated the UST at the time of the release and is a responsible party for the site as he had control of a UST at the time of or following an unauthorized release of a hazardous substance (Definition 4).
