Dear Mr. McKenna,

The Alameda County Eden Consolidated Fire District's Fire Station located at 164<sup>th</sup> Avenue in San Leandro is currently an active open leaking underground storage tank case with Alameda County's Local Oversight Program (LOP). As an active case, the site must be "claimed," and if applicable, all analytical data beginning September 1, 2001 must be electronically transmitted to the State Water Resources Control Board's GeoTracker website. In addition, beginning July 1, 2005, all reports must be uploaded to GeoTracker as PDF documents. Currently, your site is "unclaimed" in GeoTracker rendering the site to non-compliance status. At this time, the only requirement is to "Claim" your site in GeoTracker since no site assessment work appears to have been conducted after 2001. Please claim your site in GeoTracker by August 15, 2008. Attached is a letter mailed to the County Administrator that summarizes the GeoTracker requirements for your site.

The LOP has also evaluated your file to determine whether the site qualifies for case closure. Based on our review, it appears that an underground storage tank was removed in January 1989. Analytical data transmitted via facsimile identified Oil and Grease in a soil sample at a concentration of 280 mg/kg. A tank removal report documenting removal activities could not be found in our case file. Therefore, a case closure evaluation could not be conducted for this site due to a lack of data. Please submit all reports or data you may have for the above-mentioned site by August 29, 2008. Once all the reports and data have been submitted, an evaluation can be performed to determine whether you site qualifies for case closure.
