Hello Keith,

This is a follow-up to a voice mail I just left you. I just wanted to let you know:

- We have uploaded the previous annual groundwater sampling report to GeoTracker (documentation attached). All electronic lab data (EDFs), depth to water (Geo-Wells) and updated figure (Geo-Map) will be reuploaded tomorrow.
- We have also uploaded the *Updated Site Conceptual Model* report (2011) that was previously uploaded to the ACEH FTP site, but not to GeoTracker (mentioned as an impediment in the <u>Path to Closure Plan</u> on GeoTracker).
- We will forward the signed <u>certification statement</u> later this week when the responsible party (Mr. Lynn Worthington) gets back into town (blank copy attached).

I will touch base with you tomorrow (or please feel free to call anytime), to provide a brief verbal update and arrange for a meeting to review criteria needed to move the site towards closure under the <u>Low Threat Closure Policy</u>. Ideally, we could meet out at the site itself to: 1) see the close proximity of the off-site gasoline plumes that are encroaching onto the subject Site; 2) look at the tight spacing of the former Remediation Wells (RWs) still on site; and 3) visualize what it would take to confirm that "secondary source has been removed to the extent practicable" (i.e., additional impediment to LTCP site closure).
