Thank you Kyle. That was an accurate synopsis of our discussion.

As you mentioned, following workplan approval, we will be going out to Install shallow piezometers and collect water samples (if water is present) to provide evidence to support the confined zone CSM and to confirm that hydrocarbons have not migrated in groundwater moving through the shallow soils above the confining layer. We will also be collecting soil vapor samples (conditions permitting) to confirm there is no vapor intrusion risk; and

This may be implied, but one comment I'd like to add/reinforce as we believe it is important:

- If water does not accumulate in the piezometers, and/or water samples from the piezometers do not contain elevated benzene, we believe our confined zone CSM would then be validated. It would verify our belief that the numerous (14), long-screened wells that perforate dry soils beneath this relatively small commercial site act to exacerbate plume migration by cross-contaminating residual, UST-release soil impacts with confined aquifer waters. As such, the existing well network: 1) does not properly represent site conditions; 2) acts as a driver to spread contamination; and 3) are not of any use (particularly with the existing 20-year record of groundwater data).
- So if the collected data shows: 1) no vapor intrusion risk, and 2) a lack of elevated benzene in the shallow piezometers (if water is present), we would like to get authorization to properly destroy the long-screened wells at the site.
