Provided the Alameda County Department of Environmental Health (ACDEH) is provided a work plan or scope of work prior to the investigation, and a site investigation report after the work has been undertaken, ACDEH does not object to undertaking the subsurface work. ACDEH is interested in this work as the parcel appears associated with an open environmental case (RO2728) that has been inactive since 2006, and which upon review of site data contains contaminants at levels of concern to ACDEH and to the general public.
